Towable RV Return Form

This form is completed upon the return of the RV. The form must be completed. Incomplete forms, forms that have been altered after signature, and forms that have been crossed out or overwritten may result in denial of any security deposit or insurance claims.

Step 1: Damage Walkthrough

In this section, you will record any damage that occurred during the RV rental that was not noticed prior to rental. All damages must be photographed and uploaded via the app or Owner Dashboard on web. You must do a comprehensive review of the condition of the entire interior and exterior, including the undercarriage and the roof. Although you have 48 hours to report damages to Outdoorsy, it is strongly encouraged that you discover and document any and all damages now so that the renter can sign off on them. This will eliminate the possibility of a claim or security deposit dispute.

After the unit has been returned, the owner has up to 48 hours to request any claims against the security deposit or request additional charges be made to the renter (i.e. variable fees).

In order to file a claim, you will need:

- Pre-trip and post-trip photos
- 90-day inspection forms
- Signed RV departure form
- Signed RV Return form

The renter has up to 48 hours to pay the additional fees or dispute the claims. Settled claims in excess of the security deposit may be charged to the primary renter's credit card on file with Outdoorsy.

Note that all security deposit claims and additional charges are subject to a 2.95% credit card processing fee that the vehicle owner may pass to the vehicle renter
